The Department agrees to supply the Licensee a Fibre Allocation from Crown timber in the amount of up to 200,000 GMT of softwood and hardwood pulpwood, sawlog, and studwood material Primary Forest Product usable in the Licensee's operations such that the allocation is 100,000 GMT for the term from August 1, 2018 to July 31, 2019 and 100,000 GMT for the term from August 1, 2019 to July 31, 2020 and this fibre allocation includes:

3. All other provisions of the Original Agreement remain in effect, unamended.
