

THIS THIRD AMENDING AGREEMENT made this 17th day of *September*, 2019.

BETWEEN:

HER MAJESTY THE QUEEN in right of the Province of Nova Scotia, as represented in this behalf by the Minister of Lands and Forestry (hereinafter referred to as "the Department")

OF THE FIRST PART

-AND-

Westfor Management Inc., a company incorporated under the laws of Nova Scotia (hereinafter referred to as the "Licensee")

OF THE SECOND PART

WHEREAS the parties entered into an Agreement between NSDNR and the Licensee dated October 11th, 2017 (the Agreement);

AND WHEREAS the parties entered into an amending agreement (First Amending Agreement) dated June 26, 2018, to extend the term to September 30, 2018;

AND WHEREAS the parties entered into a further amending agreement (Second Amending Agreement) dated October 9, 2018, to extend the term of the Agreement to September 30, 2019;

AND WHEREAS the Licensee has requested a further one-year extension;

AND WHEREAS the parties recognize that the fiber allocation stated in clause 4.2 and set out in Schedule "A" is required to be adjusted;

NOW THEREFORE this Third Amending Agreement witness that in consideration of the mutual covenants and agreements contained herein, the parties agree as follows:

1. Paragraph 2.1 of the Agreement is amended changing the term of the agreement to October 1st, 2017 until the 30th day of September 2020.
2. Schedule "A" in the Agreement is amended by changing the fibre allocation to:
